
How does advanced Q&A forwarding work?

ONLINE VIEWER FOR MICROSOFT® OFFICE FILES




Sharing confidential information contained in Microsoft Excel® files with third parties presents a challenge to document owners who wish to restrict access to view-only, without the ability to copy, print or download.

One awkward solution is to convert Excel files to PDF format to enable online viewing. Another solution is to utilise the security features of IRM (Information Rights Management) in Office, so that authorised users can download a protected, watermarked copy of the Excel workbook with restrictions on copying, printing, and forwarding to unauthorised recipients. However, IRM may present challenges to some users' devices and IT systems and requires Office to be installed on the client device.



How does the Sterling online viewer for Microsoft Office files work?



Sterling has released a secure, online viewer which enables users to view Office files, including Excel workbooks, in their original, native

format on any device, without having to download or install any additional software. VDR settings can be enabled to force all Office files to

only open in the viewer, or allow users to download IRM-protected, native Excel files.


ONLINE VIEWER FOR COMPUTER AIDED DESIGN FILES



CAD files are used in many industries, especially energy, real estate, construction, engineering, aeronautics, and automotive. VDR managers are usually forced to relax security restrictions and allow users to download unprotected CAD files or resort to an unwieldy print-to-PDF option.
